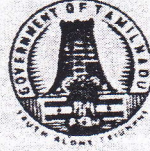

ORDER:

The Government have sanctioned the formation of three subsidiary canteens at TSP I Battalion, Trichy, TSP VI Battalion, Madurai and TSP Regiment Commandant, Avadi, in the Government order first read above. Further the Government have sanctioned the formation of 44 Police Canteens in the Government order third read above. The Government have also sanctioned a sum of Rs.7,90,000/- each to establish two canteens in Chennai at Pudupet (Egmore) and Kondithope vide Government orders fourth and fifth read above.

2. In his letter sixth read above, the Director General of Police, Chennai has requested to form a new Police Canteen at Tamil Nadu Police Academy, Oonamancherry considering the welfare of the staff and their families at Tamil Nadu Police Academy, Oonamancherry and the difficulties faced by them to Commute to the Canteen at St.Thomas Mount and also to extend the Canteen facilities to the Police Personnel who are residing in and around Tamil Nadu Police Academy.

3. The Director General of Police, Chennai has requested to sanction a sum of Rs.7,90,000/- only for the formation of Police Canteen at Oonamancherry, as the building for canteen is readily available at Tamil Nadu Police Academy, Oonamancherry.

4. The Government after careful examination have decided to accept the proposal of the Director General of Police, Chennai and to sanction a sum of Rs.7,90,000/- towards the formation of a new Police Canteen at Oonamancherry, as the building for canteen is readily available at Tamil Nadu Police Academy, Oonamancherry. Accordingly, the Government accord administrative and financial sanction for Rs.7,90,000/- (Rupees Seven lakh and ninety thousand only) under the heads of account as mentioned in the Annexure to this order for establishing a new Police Canteen at Oonamancherry at Tamil Nadu Police Academy, Oonamancherry.

5. Necessary funds will be provided in Revised Estimates/Final Modified Appropriation 2018-19 to meet the expenditure sanctioned in para 4 above. Pending provision of such funds, the Director General of Police is authorized to incur the expenditure. The Director General of Police is directed to include the amount sanctioned above, while sending the budget proposals for Revised Estimates / Final Modified Appropriation 2018-2019 to Government in Finance (Home-I) Department at the appropriate time without fail.
