ORDER:-

In the Government Order first read above, orders have been issued extending the Police Canteen facility to all the Uniformed Personnel belonging to Fire and Rescue Services and Prison Department based on the announcement made by the Hon'ble Chief Minister on the floor of Assembly on 24.04.2012 and 03.05.2012.

2. In his letter second read above the Director, Fire and Rescue services has stated that in Tamil Nadu Police Department all the Ministerial Staff are availing canteen facilities along with the uniformed Personnel of their Department, as per the instructions issued by the Ministry of Home Affairs, Government of India vide their letter No.DA_VII/CPC/2012, dated. 30.04.2012 and based on the above said instructed the respective commandants through the Inspector General of Police, Armed Police, Chennai to extend the canteen facilities to the Serving / Retired Ministerial / Miscellaneous staff and their families and the families of the deceased Ministerial / Miscellaneous staff in Tamil Nadu Police Department are availing the canteen facilities along with uniformed personnel of that Department.

3. The Director, Fire and Rescue Services has therefore requested for Government Orders to extend the Police Canteen facility to the Ministerial Staff in

Tamil Nadu Fire and Rescue Services Department on par with that of the Ministerial Staff attached to Tamil Nadu Police Department. He has also added that (except VAT exemption) there is no financial commitment involved for extending the Police Canteen facility to the Ministerial Staff of Fire and Rescue Services Department.

4. While replying to the Demand No.23, on the floor of Assembly on 26.06.2018, the Hon'ble Chief Minister among other announcements has made the following announcement:-

5. Pursuant to the announcement made by the Hon'ble Chief Minister, the Government have decided to accept the proposal of the Director, Fire and Rescue Services. Accordingly, the Government hereby order that the Police Canteen facility be extended to the Ministerial Staff of Tamil Nadu Fire and Rescue Services Department on par with that of the Tamil Nadu Police Department.

6. The order issues with the concurrence of the Finance Department vide its U.O.No.41076/Home-II/2018, dated 14.08.2018.
