3. The Government have examined the above proposal of the Director General of Police and decided to accept the proposal with revised cost estimate. Accordingly, the Government accord sanction a total sum of Rs.6,55,60,000/- (Rupees Six crores fifty five lakhs and sixty thousand only) for establishing Tamil Nadu Subsidiary Canteens at the rate of Rs.14,90,000/- (Rupees fourteen lakhs and ninety thousand only) for the following canteens at 44 places viz. 32 Districts (including Commissionerates) and 12 Battalions:-

2. Based on the above announcement, the Director General of Police has sent proposals in his letter 3rd read above for sanction of Rs.13.20 Crores for setting up of 44 Police Subsidiary Canteens at 32 Districts and 12 Battalions in addition to the Canteen already set up at Chennai.

The Hon'ble Chief Minister has announced on the floor of Assembly while replying to the demand on 23.04.2013 that Police Canteens would be set up in 45 places.

4. The expenditure sanctioned in para 3 above shall be debited to the heads of account as mentioned in the Annexure to this order.
5. The amount sanctioned in para 3 above will be drawn by the Director General of Police on the basis of progress of work and Utilization Certificate submitted to Director General of Police by Tamil Nadu Police Housing Corporation Limited and should be contra credited into Personal Deposit Account of Tamil Nadu Police Housing Corporation Limited in the following Head of Account:-
 "K - Deposits and Advances (b) Deposit not bearing Interest - 8443 - 00 - Civil Deposits - 800 - Other Deposits - BL - Deposits of Tamil Nadu Police Housing Corporation"
 (DPC 8443 - 00 - 800 - BL - 000A) (Receipts)
 (DPC 8443 - 00 - 800 - BL - 0000) (Outgoings)
 by means of Cheque in favour of Personal Deposit Account of Tamil Nadu Police Housing Corporation Limited.
6. The Government direct that the work of construction be entrusted to Tamil Nadu Police Housing Corporation Limited. The chairman and Managing Director, Tamil Nadu Police Housing Corporation Limited is directed to ensure that the construction work is completed within the sanctioned amount or tendered value of work whichever is less.
7. The expenditure sanctioned in para 3 above shall constitute an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by sanction of an advance from the Contingency Fund, orders regarding which the Government in Finance (BG.I) Department will issue. The Director General of Police is directed to apply to Government in Finance (BG.I) Department, in the prescribed format along with a copy of this order for sanction of an advance required for the current year (2014-2015) from the Contingency Fund.
8. The Director General of Police is also directed to send a draft explanatory note, indicating the total cost of the scheme, the cost that would be required for the implementation during the financial year etc., to
