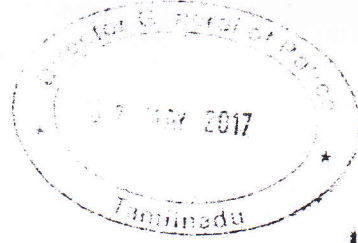

**ORDER:**

In the Government order first read above, the Government have accorded administrative and financial sanction for a sum of Rs.1.00 Crore (Rupees one Crore only) as one time grant for three Police Subsidiary Canteens in three places at (i) RC, Avadi, Chennai (ii) TSP I Bn. Trichy and (iii) TSP VI Bn. Madurai and these Police canteens have started functioning from 28.03.2012.

**D. G. P.** 2. In the Government order second read above Government have sanctioned a sum of Rs. 64,24,077/- (Rupees Sixty Four lakhs Twenty Four Thousand and seventy seven only) for the construction of exclusive Police Canteen for the Chennai City Police at Egmore. The building sanctioned in the Government order second read above was constructed and taken over in possession on 13.04.2016 by the Assistant Commissioner of Police, Armed Reserve -I, Chennai City.

3. In the Government order third read above, Government have sanctioned a total sum of Rs.6,55,60,000/- (Rupees Six crores fifty five lakhs and sixty thousand only) for establishing Tamil Nadu Police Subsidiary Canteens at the rate of Rs.14,90,000/- (Rupees fourteen lakhs and ninety thousand only) per Canteen at 44 places viz. 32 Districts (including Commissionerates) and 12 Battalions, all these canteens have started functioning from 15<sup>th</sup> September 2015.

4. In the letter fourth read above, the Director General of Police has sent a proposal for establishing Canteen at Pudupet (Egmore) in the building sanctioned in the Government Order second read above to provide easy access to the beneficiaries from North/Central/Eastern parts of Chennai City. The amount required to start an additional Police Canteen is Rs.7,90,000/- (Rupees Seven Lakhs Ninety Thousand only). Therefore Director General of Police has requested the Government to sanction a sum of Rs.7,90,000/- (Rupees Seven Lakhs Ninety Thousand only) under the relevant heads of account (as mentioned in Annexure -I) to establishing one additional Police Canteen at Pudupet (Egmore).

5. The Government, after careful examination have decided to accept the proposal of the Director General of Police Chennai to sanction Rs.7.90 lakhs for establishing one additional Police Canteen at Pudupet in the newly constructed building. Accordingly the Government accord administrative and financial sanction for a sum of Rs.7,90,000/- (Rupees Seven Lakhs and Ninety Thousand only) under the heads of account as mentioned in Annexure -I to this order for establishing one additional Police Canteen at Pudupet (Egmore) in Chennai.

6. Necessary funds will be provided in Revised Estimates/Final Modified Appropriation 2017-2018 to meet the expenditure sanctioned in para 5 above. Pending provision of such funds, the Director General of Police, is authorized to incur the expenditure. The Director General of Police is directed to include the expenditure sanctioned above, while sending the budget proposals for Revised Estimates / Final Modified Appropriation 2017-2018 to Government in Finance (Home-I) Department at the appropriate time without fail.

7. This Order issues with the concurrence of Finance Department vide its U.O.No.18467/Home-I, dated 19.04.2017 and Additional Sanction Ledger No.198 (One Hundred and Ninety Eight)
