ORDER:

In the Government Order first read above, the Government vested the administration of the Tamil Nadu Police Centenary Scholarship scheme to a committee consisting of the officials mentioned therein. In the Government order second read above, the Government have reconstituted the committee consisting of the officers specified therein. In the Government Order third read above, the Government have again reconstituted the committee with the following officers:-

In the letter fourth read above the Director General of Police has informed that the Tamil Nadu Centenary Scholarship is awarded to the deserving children of the Police Personnel up to the rank of the Inspector of Police and Ministerial Staff upto the rank of the Superintendent and other Auxiliary Staff for pursuing higher education beyond XII Standard. The Children of retired / deceased Staff of these ranks are also considered for the scholarship for a period of five years from the date of superannuation retirement / death. One time scholarship ranging from Rs.4,200/- to Rs.12,000/-, is sanctioned to the children of the subscribers for higher studies i.e. beyond XII Standard, from Tamil Nadu Police Benevolent Fund and also from the amount of interest received from the donations of Private Charities, deposited with the Treasurer, Charitable Endowments for maintenance, Kuralagam, Chennai.

3. The Director General of Police has also added that the subject of Tamil Nadu Police Centenary Scholarship and other welfare schemes in Welfare Wing are allocated and handled by the Additional Director General of Police, Welfare and Inspector General of Police, Welfare. But, the existing committee governing the Tamil Nadu Police Centenary Scholarship Fund does not have Additional Director General of Police, Welfare / Inspector General of Police, Welfare as members. Hence, the Tamil Nadu Police Centenary Scholarship Administrative Committee may be reconstituted with the following officers:-

- 1. Additional Director General of Police, Welfare - President
- 2. Inspector General of Police, Welfare - Secretary
- 3. Additional Commissioner of Police, Head Quarters, Chennai - Member
- 4. Inspector General of Police, North Zone - Member
- 5. Deputy Inspector-General of Police, Armed Police, Chennai - Member
- 6. Deputy Inspector-General of Police, CBCID, Chennai - Member

The Director General of Police has further added that the Tamil Nadu Police Centenary Scholarship have been awarded to the wards of Personnel pursuing higher studies beyond XII Standard up to the Academic year 2014-2015.

4. The Director General of Police has therefore requested the Government to issue orders for reconstituting the existing Tamil Nadu Police Centenary Scholarship Administrative Committee as suggested on para 3 above for administrative convenience.

5. In the letter 5th read above, the Director General of Police has sent a draft notification proposal for approval of the Government.

6. The Government approve the proposal of the Director General of Police in the letters 4th and 5th read above. The following notification will be published in the next issue of the **Tamil Nadu Government Gazette:-**

NOTIFICATION

In the matter of the Charitable Endowments Act, 1890 (Central Act VI of 1890) and in the matter of "The Tamil Nadu Police Centenary Scholarship Scheme".

WHEREAS application has been made to the Government of Tamil Nadu under sub-section (1) of section 6 of the charitable Endowments Act, 1890 (Central Act VI of 1890), by the Director General of Police, Chennai for modifying the Tamil Nadu Police Centenary Scholarship Scheme, settled under the said Act for the administration of the Tamil Nadu Police Centenary Scholarship Fund, published at pages 1418-1419 of Part-II Section I of the Fort St. George Gazette, dated the 1st August 1962, as subsequently amended.

NOW, THEREFORE, in exercise of the powers conferred by section 5 of the said Act, the Governor of Tamil Nadu hereby makes the following modifications to the said Scheme, and appoints the date of publication of this notification in the Tamil Nadu Government Gazette as the date on which the said scheme as so modified shall be deemed to have come into operation.

AMENDMENTS

In the said scheme for clause 2, the following clause shall be substituted, namely:-

"2. The Committee for the administration of the Scheme shall consist of:-

1. Additional Director General of Police (Welfare) - President
2. Inspector General of Police (Welfare) - Member - Secretary
3. Additional Commissioner of Police, Head Quarters, Chennai. - Member
4. Inspector General of Police, North Zone, Chennai. - Member
5. Deputy Inspector General of Police, Armed Police, Chennai. - Member
6. Deputy Inspector General of Police, Crime Branch, Crime Investigation Department, Chennai". - Member
