ORDER:

In the Government Order second read above, the Government issued orders for the enhancement of ex-gratia payment to the next kin of the police personnel working in the Tamil Nadu Police who are killed / disabled / injured under heroic or tragic circumstances in the course of duty at the following rates:-

2. The Hon'ble Chief Minister on 24.03.2020 during the Budget announcement for the demand No.22 (Police Department) for the year 2020-2021, among others made the following announcement:-

3. Consequently, the Director General of Police in his letter dated 27.05.2020 has stated among others and send the following proposal to the Government:-

He has further stated that every year Rs.60,00,000/- have been allotted in Budget Estimate for the payment of Ex-gratia under the relevant Head of Account. In the event of Ex-gratia amount being enhanced at the above said rates, he has requested the Government to sanction a sum of Rs.1,50,00,000/- under the relevant Head of Account. He has therefore requested the Government to issue orders to that effect.

4. The Government after examining the proposal of the Director General of Police in pursuance of the announcement of the Hon'ble Chief Minister, order for the enhancement of ex-gratia amount with effect from the date of issue of this order payable to the next kin of the police personnel and the police personnel working in the Tamil Nadu Police who are killed /disabled / injured under heroic or tragic circumstances in the course of duty, as detailed below:-

- 6. The Director General of Police has been directed to incur the expenditure for the said purpose within the funds available (i.e. Rs.60,00,000/-) in Budget Estimate 2020-2021. If additional funds required, necessary proposals may be sent to Government along with proposals for Revised Estimate / Final Modified Appropriation 2020-2021 at the appropriate time.
